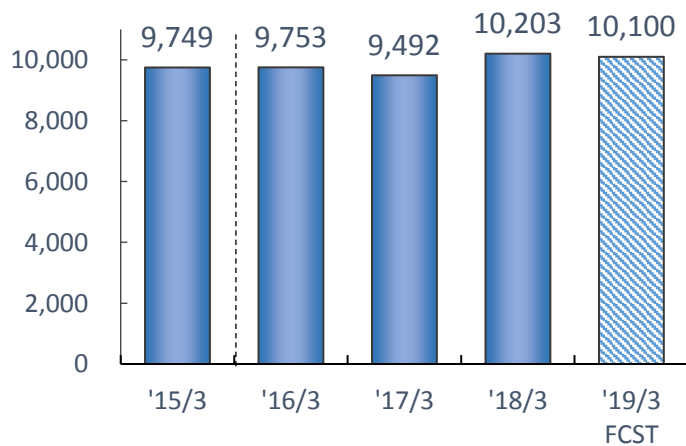

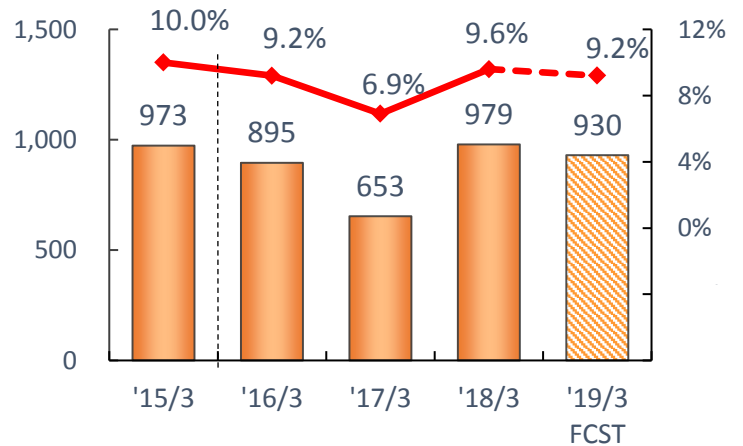

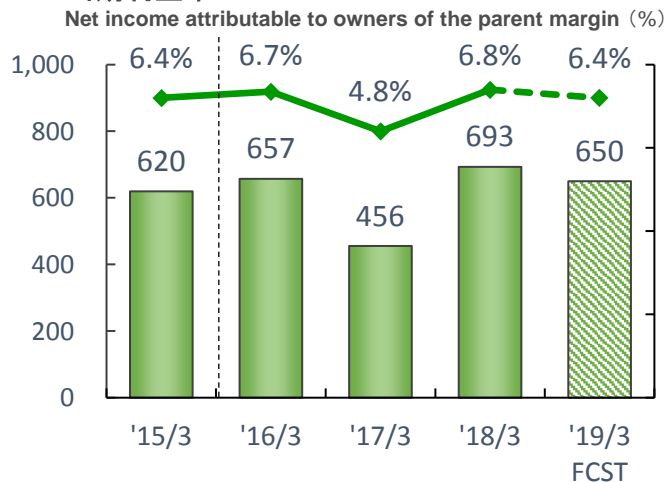
売上高 Net sales (億円/¥100 Million)



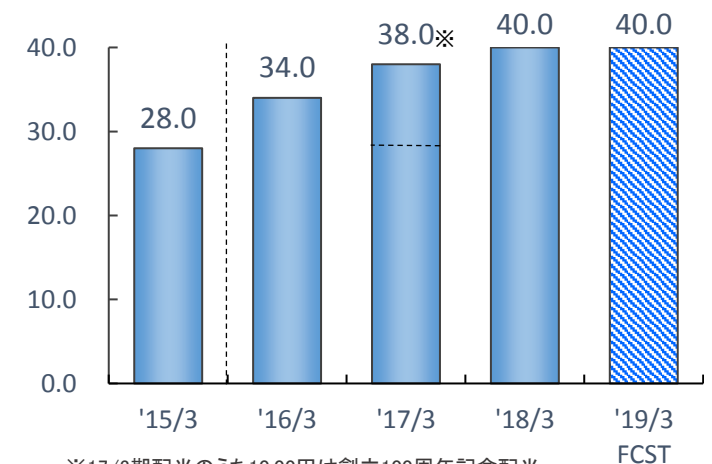
営業利益 Operating income (億円/¥100 Million)

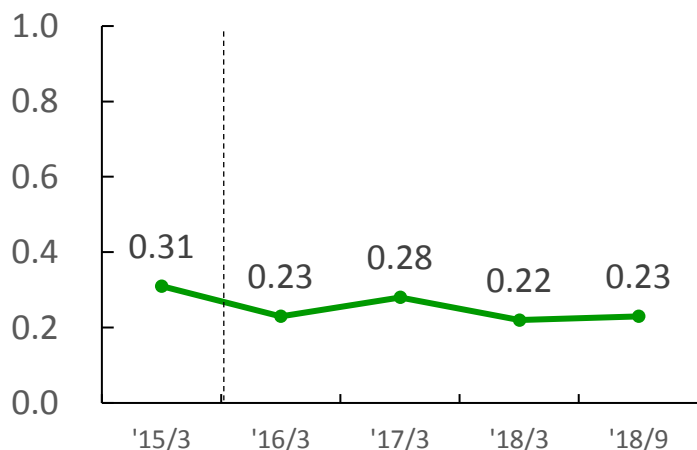

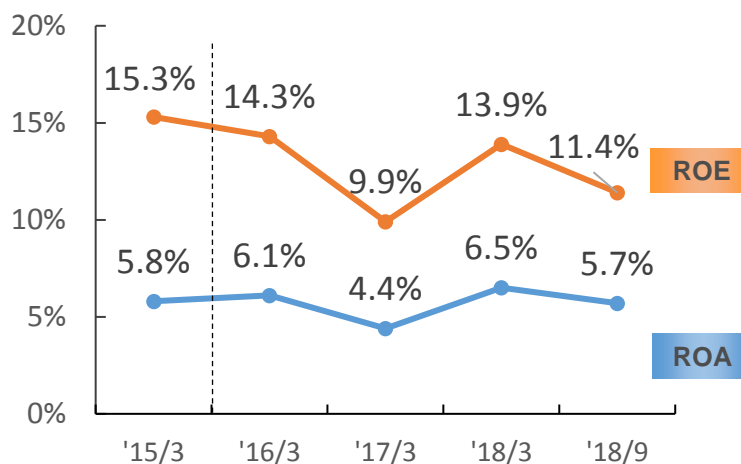

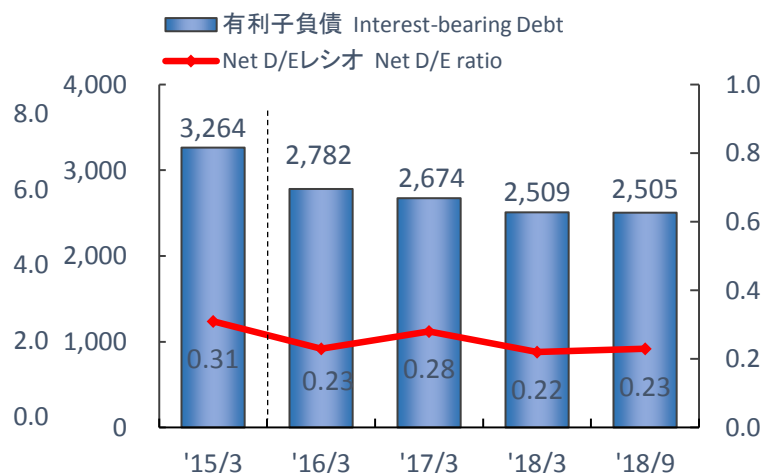
