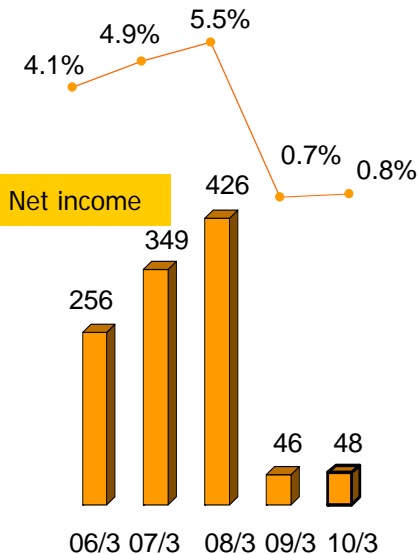

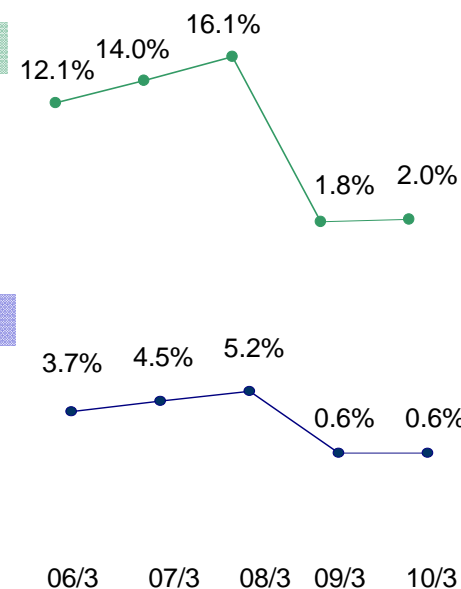
自己資本比率 Equity ratio



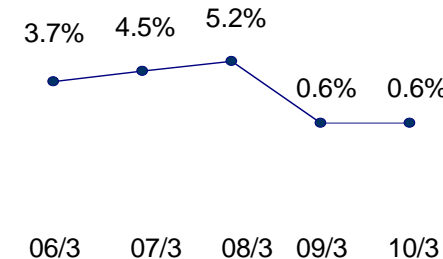
自己資本 Shareholders' equity
